## **Economic scenario of UAE**

The UAE has a dynamic economy, which is diversifying quickly as it aims to transform itself into a knowledge economy. The UAE's openness to international business and strategic location as a gateway to the region, create business opportunities and present UAE as an attractive market for Indian exporters. The UAE's stable and resilient economy recovered significantly, expanding by 7.9% in 2022 after the Covid-19 crisis.


The UAE stands out as one of the promising markets in the Middle East and Africa region, due to its forward-looking outlook and ambitious vision. On the 2023 edition of the U.S. News & World Report, the UAE secured the 19th position among 85 of the world's best countries, leading in the movers sub-ranking, which evaluates nations' potential for economic advancement. Additionally, UAE ranks 19th in the 2022 FREOPP World Index of Healthcare Innovation, up from 20th in 2021 and 22nd in 2020.

UAE is the country among the fastest growth rate in healthcare spending in the Middle East, with healthcare expenditures expected to reach USD 30.7 billion by 2027 at a compound annual growth rate (CAGR) of 7.4%. Through continued focus on innovation and growth, the country is constantly improving its global healthcare collaborations with significant attention to its hospital and medical Centre infrastructure. This expansion will enable Indian exporters to capitalize on these emerging opportunities across diverse sectors in the UAE.






## India and UAE's Bilateral Trade

The UAE ranks among the top five export destinations for India's engineering industry, standing as the largest within the WANA region. From 2018-19 to 2023-24, Indian exports to the UAE surged from USD 30.1 billion to USD 35.6 billion. UAE's imports of engineering goods from India also witnessed a significant uptick, soaring to USD 5.9 billion in 2023-24 from USD 3.1 billion in 2020-21

The product profile of Arab Health 2025 consists of Medical Device & Supplies and other related products. In 2022 (ITC Trade Map), India's export of Pharmaceutical Machinery, Medical and Surgical Equipment to the UAE totaled USD 44.7 million, representing a mere 3.2% share of the UAE's total import of such instruments. During same time, India ranked 12th among the UAE's suppliers of medical machinery and devices, indicating significant untapped potential in this market.

## Opportunity for Indian Medical devices Industry in UAE

As one of the most advanced and dynamic markets in the Middle East, the UAE already has a strong healthcare infrastructure and is quickly adding clinical research and manufacturing capabilities. Leveraging this world-class healthcare infrastructure to make the UAE into a regional healthcare innovation hub with medical tourism and medical-grade logistics is a top priority for the UAE. These initiative seeks to meet the evolving needs of the UAE, while positioning the nation to become a regional medical tourism hub for specialty treatments that are not available elsewhere. Thus, presenting a hopeful outlook for Indian medical devices exporters.

Recent world events such as the Covid-19 pandemic, prompted the UAE to redouble its commitment to investing in healthcare and develop the sector. There are numerous new hospital construction and renovation programs underway. Also, growing medical tourism sector is boosting demand for modern facilities with the latest medical equipment, meaning significant business opportunities for Indian medical devices manufacturers.

## **Selection criteria**

Since limited space is available, selection of participation will be done strictly on first-come, first-served basis.

## **Cancellation of participation**

Please note that no request for cancellation and/ or refund including of advances, if any and/ or adjustment thereof shall be accepted for any reason whatsoever. Once the application form and/ or advance/ part payments are accepted by EEPC India the participant remains liable to pay in entirety the amounts due from them on account of the event. In case members are not able to travel due to travel restrictions/advisory by Government of India or United Arab Emirates then the amount paid will be adjusted toward the participation in the next edition.





# **Force Majeure**

If a Force Majeure Event like war, act of God, natural calamities, governmental directives, civil commotion, epidemic, pandemic, etc. or alike events occurs inasmuch as that the fair authorities/ organizers consider that it is illegal, impossible, inadvisable or impracticable for the physical, onsite and in-person (i.e. 'live') elements of the Event to be staged, then in such situation and/or circumstances the decision of the fair authorities shall be final and binding upon EEPC India and all its co-exhibitors/ participants. In such situation and/ or circumstances, if the fair authorities, organizers or the vendors appointed for providing diverse services related to the Event in question does not refund the monies paid by EEPC India and/ or does not otherwise absolve EEPC India from its contractual obligations then in such case the Co-exhibitors / participants remain liable to pay to EEPC India the contracted participation charge in full and shall not receive any refund from EEPC India of the amounts paid by the co-exhibitors/ participants. Further, if the fair authorities, organizers or the vendors, so appointed for the Event binds or rolls over EEPC India's participation in the future editions of the same Event in question, then automatically the participation of the co-exhibitor/ participant shall also be carried forward to such future editions of the Event and the amounts paid by them shall be given a credit for the successive edition. However, if there is any increment in the participation fees fixed by the fair authorities, organizers or in any other charges, budgets, etc. then such increased amount has to be paid by the co-exhibitor/ participant without any demur based on the space and booth booked by the co-exhibitor/ participant. In any event, a co-exhibitor/ participant cannot decrease the space or the booth size booked by them for the originally scheduled Event.

**Note:** Regarding goods taken out of India for exhibition or on consignment basis for export promotion, participants may refer to Circular No. 108/27/2019-GST dated 18.07.2019 of the Central Board of Indirect Taxes and Customs (CBIC) which is the statute in the matter.
